## NEUROSTAR CLINICAL OUTCOMES STUDY UPDATE

Enrollment is now closed for the NeuroStar Clinical Outcomes Study. This observational study, being conducted by Neuronetics, Inc., has reached its goal of 300 evaluable patients gathered from over 40 clinical locations across the country.

In April, we reported the preliminary findings of the first 99 patients enrolled in the study. Now, with data from the full population of 300 patients, the study can move forward in analysis on a much larger scale.

Follow-up analysis will assess patients' progress for a year after completion of their acute treatment phase. The follow-up period is projected to be completed by September, 2012.

The study, which aims to examine the effectiveness of TMS therapy in a clinical setting, has already yielded exciting preliminary results. The information gathered from this study will be incorporated into many realms, from clinical use to insurance reimbursement purposes. We look forward learning more about TMS therapy in long-term settings through the final analysis.

We look forward to sharing the full study results as soon as they are published.

#### HEARING LOSS AND DEPRESSION

A large-scale study conducted by the National Council on Aging demonstrates the importance of hearing healthcare in maintaining mental health. The study found that individuals over the age of 50 with untreated hearing loss were more likely to report depression, anxiety, emotional instability and paranoia. The degree of depression and other mental health issues increased with the severity of hearing loss.
